



## **Collection of School Meals Money and School Debts Policy**

## **Introduction**

This policy concerns the collection of school meal money and the approach to be taken in the case of debts arising when parents/carers fail to pay for school meals. This policy will be published on the school website and parents/carers advised of the policy when their children start at Rodings Primary School and through periodic reminders.

## **General Principle**

School meals must be paid for in advance. If a child is to have meals for the duration of the week, monies must be received before the start of that week or as we accept children having an occasional meal, monies must be received on the day of the meal.

If debts are incurred, then the school budget has to pay for them. This means that money which should be spent on all children's education in school is used to pay for debts incurred by individual parents/carers. The governing board see this as unacceptable and request that all parents/carers give this policy their full support.

## **Free School Meals Entitlement**

Children in the Foundation Stage and Key Stage 1 receive Universal Free School Meals.

Children in Key Stage 2 will not be provided with a school meal unless it is paid for, except those confirmed as entitled to Free School Meals. If parents/carers believe that their child(ren) may qualify for entitlement to Free School Meals they should contact the County Council. As this allowance is a statutory right for qualifying children it is important that parents/carers make use of it. The school is only allowed to provide free school meals to children where this is officially approved and informed in writing by the Local Authority.

## **Procedure for Collection of Arrears**

It is accepted that on occasion arrears may arise for various reasons. However, arrears cannot be allowed to accumulate. The governing board has therefore agreed the following policy where arrears arise.

A system generated email via Arbor will be sent home on every day a meal is ordered with no payment.

A gentle reminder email will be sent home after 10 accumulated meal arrears (see Appendix 1).

A second email will be sent to the parent/carer if the arrears still haven't been cleared two weeks after the first reminder email. This will state that with

immediate effect no further school meals will be provided for their child(ren) and the debt must be cleared within five working days (see Appendix 2).

A final email will be issued four weeks after the first letter if the arrears have still not been cleared. This informs the parent/carer that once the final five working day deadline has expired the debt will be passed onto a debt recovery agency where legal proceedings may begin (see Appendix 3).

The procedure for collecting arrears will be conducted with sensitivity and with the aim of working with the family if there is genuine reason for the arrears accruing. Families that are experiencing financial difficulty will be offered an appointment with the School Business Manager or the Headteacher to come up with an action plan to resolve the debt.
